The President's Comments

Welcome to all.

There is important news about the issues facing the Townsville Orchid Society in these comments. Please take the time to read through what you think is relevant to you.

Cancellation of the August Meeting and the Spring Show

I wish to apologise for the late cancellation of our August meeting. I arrived home on the Saturday (the day before the meeting date) about lunchtime. By that time a number of committee members had called to advise the changes to the meeting numbers, effective immediately, that had been released that morning by the State Government. We would be restricted to only 30 able to be in the hall. I had also received a number of emails regarding the same subject. I spoke with senior members of the committee and a decision was made to cancel the meeting, which was going to be on the next day. Due to time constraints relating to the Spring Show, a decision was also made to cancel that show as we could not operate with only 30 persons in the hall at a time. I am just as frustrated as you, as I was waiting for the numbers able to attend to increase, not decrease.

Whilst some members did not see the cancellation, I was surprised and pleased by the numbers of members attending the hall on the Sunday to avail themselves of the shop and pay their membership fees.

Future Meetings.

Since the August meeting was cancelled, inquiries have been made regarding what the club can lawfully do and how do we get to that point.

The Garden Club recently held a meeting at the hall with similar numbers to our hall capacity of 60 attendees. Terry, who is also a member of the garden club, arranged to collect their reasoning to enable them to hold such a meeting. I also spoke to their President to ascertain some finer details. I made several phone calls to the Queensland Government Covid-19 hotline and as a consequence, a TOS Covid-19 Plan has been completed. In conjunction with an event checklist which will be completed and displayed, the club will be able to revert back to having 60 members in the hall.

The September meeting will proceed as scheduled. All the practices that were put in place for the August meeting will stand for future meetings, until restrictions ease. These include the plant competitions continuing and the registering of your intentions to attend the meeting. It is to be understood that if you register to attend a meeting, you will not be advised that you can attend; you will only be contacted if your attendance exceeds the permitted number of members in the hall. After registering, if you hear nothing from the Secretary you do not need to do anything else but attend the meeting.

Annual General Meeting.

This will proceed as scheduled in conjunction with the October Meeting. Nomination forms are elsewhere in this Bulletin. Remember that you cannot nominate or be nominated for any position if you are unfinancial. Whilst the club can function with some committee members missing, it cannot work if we do

not have a Secretary, Treasurer and a President. Terry Ruxton cannot return as Treasurer due to the new Constitution. We will need a new Treasurer this year. Nominations must be received by the Returning Officer 14 days prior to the Annual General Meeting. Dues for the next year have been set and it is preferred that you pay your subscriptions electronically if possible (payment details are at the top of Page 1).

Christmas Party.

There will be no usual Christmas Party this year for a number of reasons. The Committee is still open for suggestions in this regard. At the moment there probably will be a November General Meeting with plants displayed and possibly judged, followed by an afternoon tea which may be supported to some degree by club funds. (Similar to the July Meeting last year).

This will be followed by a raffle which again will not be as extravagant as last year but may be supported by the club. Nothing has been finalised. Suggestions are welcome.

Members Sales Day.

This will be held on Sunday 1st November from 9am to 2pm. Members will have to provide their own cash float and manage their own sales. It will be necessary to have people on the door to obtain personal details of sellers and attendees as required for Covid-19 contact tracing.

Something about orchids.

This is simply a great time of the year for me as it is Tolumnia time. At the moment I have about fifty plants in flower, and about the same with developing flower spikes. I will speak briefly about two plants, both of which were given to me and are flowering for the first time. The first is a species, *Tolu urophylla*, which is in an 80mm pot and has eight spikes on it. The flowers are small and in today's terms not well shaped. The bright yellow flowers are well spaced. You can see by the number of flower spikes and their ability to support themselves that these traits would be welcomed by hybridisers when creating new hybrids. The second is Tolu Tiny Tim which is a primary hybrid (a crossing of two species - *Tolumnia triquetra x Tolumnia guianensis* – both from the Caribbean). This plant is in a 50mm pot with two spikes. Flowers are reasonably big with a very nice skirt. Flowers are white with heavy speckles of red/black across the flower, (see below) Apologies for the blurry photograph. Looking at the species that made this plant I have to wonder how the two species ever produced a plant of this quality. I believe that Tolu Tiny Tim has been line bred (breeding with the best flowers of a cross to obtain higher quality flowers). One just has to marvel at the beauty of flowers produced by species in the first place but then manipulated by man to produce other plants through hybridizing which may be deemed, by some, to be far superior to the original flower. Beauty is in the eyes of the beholder.
