The President's Comments

Welcome to all.

Summer is gradually creeping upon us. The days are getting hotter and the winds just keep blowing. With that combination, I am watering more often to ensure that my plants are not dehydrating. My bush house is open-sided and no matter which direction the wind is coming from, it goes straight through.

There are new growths coming on most of my cattleyas and the new growths appear to be stronger than before. My vandaceous plants are also coming forward with new root growth and they also appear to be stronger than before. I set out, about this time last year, to improve the overall standard of growth in the bush house and while there has been an overall improvement in all my plants, I trust that there is more to come. I have crossed a number of plants and the pods are slowly forming. They have a long way to go. The October meeting will be the first of the General Meetings after the new Management Committee has been formed at the Annual General Meeting. It is always an interesting time of the year. Remember October is the first month of the new plant competitions, so bring your prize-winners and favourites to the meeting.

Our November meeting is usually a very short meeting which then continues into our Christmas Party. For any number of reasons, the Committee has decided not to hold a Christmas Party this year. There will be a normal meeting with plant competitions, then there will be some plant commentary, as well as a talk of some sort. Talks: Fertilisers and the importance of pH. by Reg Dix

Background:

- interest in orchids since he was 5 - since 1990 became great interest - mainly grows Cattleya.

Reg stressed that this is the way he does things. Quote: "Put 5 orchid growers in a room and give them a problem and they will come up with 15 different answers."

Reg's PowerPoint has been loaded onto the Society's computer – members may request a copy via the Secretary.

Some points from the talk are;

- Savannah environment is the ideal for orchids
- Time for repotting when new roots are up to 4cm in size is the time to repot.
- a variety of potting materials can be used = volcanic scoria, charcoal, expanded clay balls, perlite, river gravel, quarried rock, polystyrene chips, cork, tree fern, casuarina,
- Reg's Potting mix includes:
- 5 parts bark,
- 2 parts expanded clay balls
- 2 parts scoria
- 2 parts perlite
- 1 part charcoal
- Sterilising is important. (at least 20 minutes).
- When cutting plant uses a product called steri-prune with a cottonbud on each plant.
- Sprays whole plant with a mixture of: 5mls of growth hormone 5mls Alginox and ½ Aspro per litre of water. Concentrates on spraying the root system.

- Uses a variety of fertilisers. *Alginox in with water when fertilising with Chemical fertilisers– wetting agent. (see PowerPoint)
- Cannot use Alginox with organic fertilisers such as:
- Strikeback for Orchids (Organic), Nitrosol, Seasol
- Fertilises every time he waters.
- Uses Orchidwiz to keep a record of fertilisers he uses
- Ted Registrar's Choice: Bruno Fighera Paph Saint Swithin
 - Potting mix -bark and perlite
 - Paphs like long pots rather than the squat pots.

Peter - discussed the heat now, plants need more water. Question: How do you get rid of sooty mould?

- Alginox should kill it.
